1. **Clarification:** Drawing A-701 – Millwork in Base bid: Lobby 1001 and Private 1002 millwork are among the locations listed for Base Bid millwork items.
  - a. **Additional informant can be found on Sheet A704:** Refer to details H9 and H12, along with elevations A3, A5, A8 and A14. Additionally, enlarged pans H1, H4 and H7 for further clarifications.
2. **Clarification Sheet A201:** There is no WC#3. Room 1046 IT has P-1 on three walls and the plan West wall is WC2.
3. **Clarification Sheet A202 :** Door Type C updated to correspond with floor plans. Refer to the red clouded areas (“D”) on Opening Schedule and Door Type elevations on attached revised sheet A202.
