# 024119.13 - Selective Building Demolition

1. Clarify that the existing building has been tested for lead/asbestos and none was found in materials scheduled to be removed.

# 064100 - Architectural Wood Casework

1. Under article 2.6, paragraph I; clarify that new wood door frames shall match existing.

# 087100 – Door Hardware

1. Under article 2.2, paragraph G; remove sub-paragraph 1. Keying will be done by contractor and will be keyed to existing master. Information will be provided after project is awarded.

# 087153 – Physical Access Control System

- 1. Portal Control Devices referenced under article 2.6 shall comply with this section and be provided as specified in 087100 Door Hardware.
- 2. Clarify article 2.7 indicates that the access control software should have the CCTV integration capabilities. Actual integration with the existing CCTV cameras is not required for this project.
- 3. Under article 3.7, paragraph A; remove references to burglar alarm. Room housing control workstation shall be secured and locked.

#### 116123 – Stage Rigging

- 1. Under article 1.01, paragraph B, sub-paragraph 5; remove reference to Alternate #1. 800# hoist should be included in base bid.
- 2. Under Part 10 Schedules, remove reference to Alternate #1. Set# 9, 12, 15, and 17 should be included with the base bid.
